TRZ's Children's Programs are ready to serve your needs. Please take a minute to review and go over our Parent Handbook with your child.

The Relief Zone 2020-2021 Parent Handbook

The Relief Zone Community Youth Center is pleased that your child has chosen to participate in our children's programming. It is the mission of The Relief Zone, Inc "to equip, unify, and serve the school, church and family". TRZ is a 501(c)(3) not for profit organization that has been providing quality children's programming since January 2006. TRZ's School Age Child Care Programs are licensed by the New York State Office of Children and Family Services. (TRZ policies and procedures as well as NYS regulations are available for your review at any time.) At TRZ we strive to provide the community with quality, safe, affordable childcare.

Programs available at TRZ:

*TRZ will follow the school calendar

(We will be closed any time the school is closed EXCLUDING specified No School Dayz. No School Dayz will be held at TRZ's facility (5 Frew Run Street))

*An adult MUST sign children in/out with TRZ staff for all programs.

Jumpstart:

*Located at TRZ Facility at 5 Frew Run Street from 6:30-8:50am

*Children may be dropped off any time between 6:30-8:30am.

*Children will be will be bussed from TRZ to RHJ via FCS District bus.

*RHJ's breakfast program is available to those who choose to utilize it.

Afterschool:

*Located at TRZ Facility at 5 Frew Run Street from 3:00-5:30pm

*You MUST send a note to your child's teacher and inform him/her that your child will be attending TRZ's Afterschool Program. (BE SURE!!! To communicate any changes or adjustments in the "normal schedule" during the school year.)

*3:00pm Children are bussed from RHJ to TRZ Facility. A healthy snack is provided by TRZ. HOWEVER, children are welcome to bring their own.

*Program ends at 5:30pm.

Children picked up after 5:35 will be charged \$2/per minute/per child.

Half Dayz:

*Located at TRZ Facility at 5 Frew Run Street. Children are bussed to TRZ Facility at 11:30am.

*All children are required to bring a bagged lunch and drink.

*TRZ will provide an afternoon snack.

**Program ends at 5:30pm.

Children picked up after 5:35 will be charged \$2/per minute/per child.

No School Dayz:

*Located at TRZ facility at 5 Frew Run Street.

*All children are required to bring a bagged lunch and drink.

*TRZ will provide a morning and afternoon snack

*Program runs 6:30am-5:30pm

Children picked up after 5:35 will be charged \$2/per minute/per child.

TRZ STAFF:

The staff members of our School Age Child Care programs are carefully chosen to fill the role of child care counselor. All staff members undergo a Criminal History Record check, NYS Central Registry Database check and NYS Office of Children and Family Services Criminal History Review. Staff members receive at least 15 hours of training per year. Their training includes, but is not limited to the following areas:

*CPR/First Aid/AED

*Child Abuse Prevention and Reporting

*Child Development

*Nutrition

*Health and Safety

*Communication

TRZ staff members work as a team to plan and create an environment that will be safe, creative, and fun for each child. The staff is always willing to talk with parents or children about any concerns.

TRZ KIDZ:

The goal of TRZ programming is to provide a supportive environment in which children can grow and develop.

Children have a right to:

*To be respected.

*To have a safe and reliable environment.

*To express their creativity.

*To express emotions in an appropriate manner.

*To have staff members who care about and enjoy them.

Children Must:

*Respect the rights of self and others.

*Accept limits and rules.

*Understand that others have wants and needs. Use manners and courtesy as general behavior.

*Listen and be attentive in group situations.

*Accept responsibility for one's actions.

*Listen and follow directions... {Follow all safety rules}

*Be considerate of everyone and take care of belongings and equipment.

*Ask permission for leaving group area.

BULLYING POLICY

TRZ is committed to providing a caring, friendly, and safe environment for children in our care, so that they can learn in a relaxed and secure atmosphere. Bullying of any kind is unacceptable. That is, any use of aggression with the intention of hurting another person (including, but not limited to, physical, emotional, verbal, sexual) is not tolerated. Serious incidents of targeted aggression are documented by TRZ staff, and ongoing monitoring of the situation will occur. When attempts to change unacceptable behavior are unsuccessful, the consequences of repeated bullying may include suspension and/or termination from the program.

BEHAVIOR

A behavior problem is disruptive behavior and affects the group as a whole. There is ZERO tolerance for physical violence and bullying behaviors. The safety and well-being of each child in our care is our number one priority. When children are having difficulty following our rules, we will use the following disciplinary steps:

- *Verbal explanation to child that their behavior is inappropriate.

- *Second warning.

- *Site Director will speak with child.

- *Staff will speak with the parents and discuss the child's behavior.

- *TRZ reserves the right to suspend from the program any child who consistently displays inappropriate behavior, is continually disruptive, creating problems for other children, or who is physically aggressive.

{IF SUSPENSION of a child is related to safety concerns for program participants or staff; immediate suspension may occur and the program will not be required to follow all the steps listed above.}

TRZ PARENTS:

Parents play the MOST significant role in their child's growth and development. The Relief Zone is PROUD to provide a support system that will reflect a family's values and culture. TRZ encourages parent participation. Open and friendly communication is essential.

Parent concerns should be immediately directed to the Site Director. Details surrounding the concern will be reviewed, solutions will be discussed and an action plan will be implemented.

Communication is the best tool to guarantee your child's happiness...

HEALTH FORMS:

Up to date health forms must be filed with TRZ. A copy of health forms will be kept on file at the TRZ program. Parents are responsible for informing TRZ staff of any changes in address and phone numbers. Health form MUST be received prior to child attendance in programs.

MEDICATION:

TRZ staff does not administer medication to students in School Age Child Care Programs. According to NY State regulation 414.11 SACC programs are not authorized to administer medication. If your child needs medication, please make arrangements with the school nurse. CHILDREN WITH NEEDS FOR RESCUE MEDICATION - Epi-Pens or Inhalers MUST have Written Medication Consent Form, completed by Physician. CHILDREN may NEVER carry their own inhaler/epi pen.

SICK CHILDREN:

If a child arrives or becomes ill while attending a TRZ program the parent or emergency contact will be notified at once. For the protection of your child and others (including TRZ staff), please **DO NOT send** your child if he/she has any of the following: fever during the past 72 hours, infectious rashes, infection under treatment for less than 24 hours, vomiting, diarrhea, severe cough, head lice, conjunctivitis (pink eye) under treatment for less than 24 hours. PLEASE keep him/her at home or make other arrangements. We cannot accommodate sick children and we will call you at work to come pick your child up.

CLOTHING:

Please send your child in clothing that will allow participation. Most important item is SNEAKERS. Programs **WILL GO OUTSIDE** to play (weather permitting). Please be sure your child is dressed properly.

DRILLS:

Shelter in Place: For the safety of children, each program will be prepared to shelter in place for Environmental, Social, Facility emergency or if determined necessary by local, county or State Emergency Authorities. TRZ will conduct shelter in place drills two (2) times per school year. In the event of this type of emergency situation parents will be notified via email, REMIND text, and/or phone call.

Fire Drills: These drills will be conducted once a month. We will be talking about all situations and using different routes based on the situation within that drill.

VISITORS: Each program will require all visitors to the facility/program to:

- Currently we are limiting access to TRZ facility to children and staff due to Covid-19.
- Anyone entering the facility will have temperature taken and recorded, and will have to complete screening questions before being admitted to the facility. Anyone that has a temperature over 100 degrees, or is experiencing symptoms of sickness will not be admitted to the facility. If your child is sick, do not bring them to TRZ.
- When these restrictions change we will resume our visitation as follows:
 - Sign in upon entry to the premises;
 - Indicate in writing the date of the visit and the time of entry to the facility;
 - Clearly state in writing the purpose of the visit; and
 - Sign-out upon departure from the facility indicating in writing the time.

*All programs are operated at The Relief Zone Facility at 5 Frew Run Street. Drop-off and pick-up site will be located at the Frew Run Street door. Please see drop off/pick up procedures below for details.

2020 TRZ CHILD DROP OFF/PICK UP PROCEDURES

Drop Off:

- Pull vehicle up to facility on Frew Run Side
- Call 489-9067 or 569-2614 to notify staff of your arrival
- Staff member will meet you at your vehicle to:
 - Take & log child's temperature (Complete the attestation form and self-screen at home)
 - Ask questions:
 1. Have you or anyone in your immediate family traveled out of the area in the past 14 days?
 2. Have you or anyone in your immediate family come in contact with someone that has tested positive for the coronavirus in the past 14 days?
 3. Have you or anyone in your immediate family tested positive for the coronavirus in the past 14 days?
 4. Are you and your immediately family in good health?
 - Staff member will sign child in & walk into facility

Pick Up:

- Pull vehicle up to facility on Frew Run Side
 - Call 489-9067 or 569-2614 to notify staff of your arrival
 - Staff member will meet you at your vehicle to:
 - Take & log child's temperature
 - Staff member will sign child out & release to you
- (Complete release form for staff to sign children in/out for you)

**CHILD CARE EMPLOYEE, VOLUNTEER, PARENT, CHILD AND ESSENTIAL VISITORS
HEALTH SCREENING ONE-TIME ATTESTATION**

Before entering a child care program, employees, volunteers, parents, children and essential visitors **must complete a health screening questionnaire daily. In addition, each employee, volunteer, parent, child and essential visitor must sign and submit this form to the program one time.** Employees, volunteers, parents, children and essential visitors must answer all questions and take their temperature daily to confirm a body temperature lower than 100.0 degrees Fahrenheit. If anyone answers “Yes” to any of the questions below, they cannot enter the child care program. A parent or guardian is responsible for completing daily screening on behalf of their child(ren).

Self-Screening:

Below are the self-screening questions that employees, volunteers, parents, children and essential visitors are required to answer **daily**. If any of the answers to the below questions are “Yes,” individuals **cannot** enter the program. If the answers are “No” to all the following questions, individuals may enter the program. If employees, volunteers, parents, children and essential visitors cannot take their temperature at home, but answer “NO” to all other questions, they may report to the program to have their temperature taken on site.

1. Is your temperature higher than or equal to 100.0 degrees Fahrenheit?
2. Have you had any known contact with a person confirmed or suspected to have COVID-19 in the past 14 days?
3. Are you currently experiencing ANY of the following symptoms?
 - Cough (new or worsening)
 - Shortness of breath (new or worsening)
 - Trouble breathing (new or worsening)
 - Fever
 - Chills
 - Muscle pain (new or worsening)
 - Headache (new or worsening)
 - Sore throat (new or worsening)
 - New loss of taste
 - New loss of smell
4. Have you tested positive for COVID-19 through a diagnostic test in the past 14 days?

If you have answered “NO” to all questions, you have passed and may enter the program.

If you have answered “YES” to any question, you will not be allowed to enter the program.

Attestation: By signing this document, I agree that I will self-monitor these symptoms each day and report the outcome per the instructions above and will not enter any child care program if any of the above symptoms or conditions are present.

- 3 children = \$5.50 per child, per day, per program
- 4 children = \$5.00 per child, per day, per program
- 5 children = \$4.50 per child, per day, per program

Half Dayz:

- *\$20 per child, per day
(Family maximum of \$50 per day)

No School Dayz:

- 1 child \$30.00 per day
- 2 children \$27.50 per child, per day
- 3 children \$25.00 per child, per day
- 4 children \$22.50 per child, per day

Summer Program:

- 1 child \$30.00 per day
- 2 children \$27.50 per child, per day
- 3 children \$25.00 per child, per day
- 4 children \$22.50 per child, per day

Payments are due at the beginning of each week. Children will not be granted entry to programs until payment has been received.

*** Delinquent accounts may result in suspension from programs until balance is paid in full. ***
